Applications are invited in prescribed format (Available on ISTC Website) according to the ISTC Rule regarding disbursement of means and merit based scholarships modified in the 23rd Academic Council Meeting held on 5th March 2025, to be submitted to Mr. Madan Lal latest by 19th December 2025 (5:00 P.M).

Note 1 for Merit Based Scholarships: - The hard copy of the MERIT based scholarship application along with requisite Documents/Certificates should be submitted in Mr. Madan Lal latest by 19th December 2025 (5:00 P.M) [The tentative merit list of students shall be published by Registrar Office]

Note 2 for Means based Scholarships: - The hard copy of the MEANS based scholarship applications along with requisite Documents/Certificates should be submitted to SH. MADAN LAL latest by 19th December 2025 (5:00 P.M)

Modified Rule:

(1) Means based Scholarship: Fifty percent concession (half scholarship) on tuition fee shall be admissible to students belonging to the economically weaker section, whose parents'/guardians' income from all sources does not exceed Rs.2,50,000/- p.a. as per the table below:

Additional Clauses:

- 1. The students applying for means based stipend shall be required to submit income certificate of relevant period issued by the Tehsildar/SDM/ competent authority, along with the application form. If the given information is found to be false, or suppression of facts is detected at any stage, then the student shall deposit back all the stipend received and further action will be taken as per ISTC Rules/ provision of law.
- 2. In case, a student is eligible for both the kinds of scholarships as given in (1) and (2) above, he/she shall be considered for merit based stipend only. The eligibility as per economic criteria will be considered thereafter.
- 3. The students shall be entitled for means or merit based scholarship only if they clear all the semester exams of the entitled year in the first attempt.
- 4. Among the applicants of the means based scholarship, the student with lower income proof shall be given priority, i.e. the eligible applicants shall be further prioritized on the basis of the family income and not on the basis of merit. In case of same income for more than one applicant, merit shall be used to break the tie. In case of same income and same merit, the student having less age shall be given priority.
- 5. In case any means based scholarship position remains vacant in a particular branch, either due to applicant not available or due to applicant found ineligible, the vacant position be offered to the next eligible candidate of the same batch irrespective of the branch.
